LID Annual Board Meeting:

The annual LID (Lake Improvement District) meeting will be held on Tuesday, August 18th, 2015 at 7:00 pm. The meeting location will be at Huikko’s Bowling Center in the Meeting Room, 1207 Hwy 25 North in Buffalo. Topics in the meeting will include updates on aquatic invasive species, weed control, lake level, and the LID budget. This is a good opportunity to learn more about what is happening around the lake!

Lake Pulaski Social:

The Lake Pulaski Social will be held immediately following the annual LID Board meeting on August 18th. This is a great way to stay connected with your fellow lake homeowners and meet new residents. Huikko’s will be serving appetizers, cookies/bars, & beverages. Alcohol beverages can be purchased at the bar.

From the LID Board:

AIS Weed Control –The Pulaski Lake Improvement District (LID) contracted with Lake Restoration again this year (2015) to treat Eurasian Watermilfoil and Curlyleaf Pondweed in Lake Pulaski and Little Lake Pulaski. This year’s application was completed per the DNR guidelines and included grant funding received from the DNR of \$1,680 to treat Lake Pulaski, plus an additional grant funding received from the DNR of \$1,000 to treat Little lake Pulaski. The application area this year was again capped at a maximum of 15% of the littoral acreage. The Eurasian Watermilfoil treatment this year was 16.9 acres at a cost of \$461 per acre, and the Curlyleaf Pondweed treatment this year was 8 acres at a cost of \$571 per acre.

Zebra Mussels -This year the landing will be staffed again with surveyors. The times will fluctuate as the money budgeted last fall was reduced from \$10,000.00 to \$5,000.00 and approved at the annual meeting. These funds will go to pay for the labor cost with the City of Buffalo absorbing the balance. The City of Buffalo will be responsible for hiring and supervision of the surveyors. Note: The surveyors are not authorized to refuse entrance to the lake, as only a level 1 inspector trained by the DNR along with any Peace Officer has that ability. However, the surveyors can notify the Buffalo Police, or the Wright County Sheriff's department and take down the boater’s information to report them.

By-Laws- have been completed and approved by the Wright County Attorney and will be available to view on the website at www.lakepulaski.com prior to the annual meeting. They will need to be approved at the annual meeting, and then sent to the City Of Buffalo for final approval to become official.

2015 Budget- This will be available to view on www.lakepulaski.com prior to the annual meeting.

2015 Voting- This year voting will be different than previous years. Only one vote will be cast per Lake Pulaski Improvement District household, even if there are multiple owners for that particular household. We are requesting that you bring proof of ownership with you to the meeting, such as a utility statement or tax statement. Once you have shown this proof of ownership, you will be given a voting ballot. Votes will be counted by two non-LID board members.

DNR Rules for when pumps can be turned on:

- 1) We cannot pump prior to June 1st
- 2) We cannot pump if Lake Pulaski below 966.0
- 3) We cannot pump if Buffalo is exceeds 915.5 and Buffalo must have outward flow to Crow River.
